Casework - IPTX seeks to exonerate wrongfully convicted Texans by providing first-rate legal counsel and investigative services at no cost. In 2020, IPTX received over 1,200 requests for assistance. Legal staff, volunteer attorneys, and law clinic students engaged in case review; evaluated evidence; obtained expert assistance; and prepared appropriate cases for litigation, including legal research and drafting motions and legal memoranda. Staff prepared cases for post-conviction litigation including locating evidence through city, county, and state agencies, subpoenaing witnesses, and conducting depositions or other interviews necessary prior to litigation.

Outreach & Education - IPTX's Director of Outreach and Education, Anna Vasquez, and IPTX staff speak regularly to legal professionals, universities, civic and religious organizations, and public officials to provide education on the causes and consequences of wrongful convictions. In 2020, the transition committee was formed to help provide immediate needs when clients are released and work with social service agencies throughout the state to help clients access housing assistance, employment, and mental health services. During 2020, IPTX staff recruited the contract lobbyist for the 2021 Texas legislative session, in cooperation with the national Innocence Network.

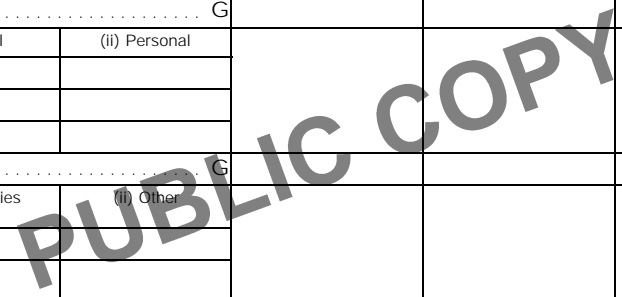

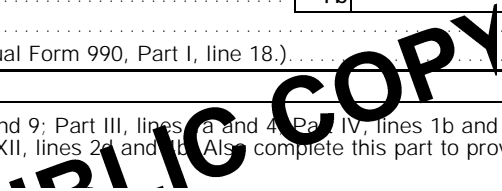

(a) whether or not to continue the transaction at issue or (b) measures to address the situation at issue. Directors subject to a conflict shall not be permitted to be present or to participate in the deliberations or vote of the qualified directors with respect to such conflict. Recusal of the director shall require such director to physically remove himself or herself from the communication. Resolution of the matter may include (a) approving or disapproving any transaction or situation at issue; (b) requiring the director to remove himself or herself from positions in which the conflict of interest exists until there is no longer a conflict; or (c) requiring the director to discontinue, reduce, or modify his or her participation in the board, committees, or task forces where the conflict exists. In addition to these procedures, directors have an obligation to address any perceived conflict of interest of other directors if they are aware of such conflicts with respect to matters pertaining to IPTX.
